## 2. Agenda Items

Discussion on Water Costs

- Work to install water shut-off valves on each floor
- Fee amounts to turn off the building water, currently set at \$300.
- Mandatory plumbing inspection to be instituted
- As problems are uncovered, install valves and newer pipes in order to protect from leaks
- Only use licensed plumbers with proper insurance

Key Audit

· All units must have current keys in the key safe

Fees for New Members

- Closing Letter fee is \$399
- The New Member Fee is two times the association fee.
- Elevators may be reserved for moving.
- No elevator reservation fee for moving moving one item like a sofa

Dog Policy

- Need to update the pet policy
- Policies will be part of "Rules and Regulations" set by the Board

## Smoking/Marijuana

- Absolutely no smoking in common areas to include the lobby, stairwells and hallways
- There is a designated smoking area near Visitor's Parking
- There will be a \$200 fine assessed to those who choose to smoke in undesignated areas.

#### Costs for Landmark Maintenance

• We have a contract for \$3,000 to do maintenance tasks at The Landmark. The current balance is past due.

## Security Recommendation

- A technician will visit to estimate to fix all the camera feeds and door lock malfunctions. This will be at no charge.
- Suggestion is to install 6 cameras, program key fobs and get everything running properly
